The papers of Henry Benton Sayler were deposited in the Dwight D. Eisenhower Library by his wife Jessie D. Sayler on June 21, 1971. An accretion was received in September 1991 from General Saylor's granddaughter Mrs. Diane Hammond.

Mrs. Sayler signed an instrument of gift for the papers on January 1, 1971. Literary rights in the unpublished writings of General Saylor in this collection and in all other collections of papers at the Eisenhower Library were retained by Mrs. Sayler until her death on December 24, 1987, and then passed to the United States. Under terms of the instrument of gift the following classes of documents will be withheld from research use:

1. Papers relating to the family and private business affairs of Henry B. Sayler.
2. Papers relating to the family and private business affairs of other persons who have corresponded with Henry B. Sayler.
3. Papers relating to investigations of individuals or to appointments and personnel matters.
4. Papers containing statements made by or to Henry B. Sayler in confidence unless in the judgment of the Director of the Dwight D. Eisenhower Library the reason for the confidentiality no longer exists.
5. All other papers which contain information or statements that might be used to injure, harass or damage any living person.

SCOPE AND CONTENT NOTE

The papers of Major General Henry B. Sayler date from 1911, when he entered West Point, until his death in 1970. They deal primarily with his associations with members of the Military Academy Class of 1915, and his army duties in the Ordnance Department during and after World War II. The majority of the documents are from the period 1942 to 1949 when General Sayler did his most notable work in the Ordnance Department. Many of the items from the period before 1942 were printed West Point mementos, which were turned over to the Eisenhower Library book collection. The papers are divided into three series.

The first series, approximately one-fourth of the total collection, is a subject file. The items in this series were received unarranged. They were placed in folders by subject, titles were devised, and the folders were arranged alphabetically. Included are both personal and official matters: (1) biographical information, awards, citations, various forms of articles and speeches, and Citizens for Eisenhower material; (2) information on ordnance-related topics such as inspection trips, statistics, research and development data, maps, graphs, memos, reports and photos; (3) correspondence, both personal and official; and (4) miscellaneous memorabilia such as clippings, souvenir booklets, programs, special letters and so forth.

The second series, approximately one-fourth of the collection, consists of material related to the USMA Class of 1915. It is primarily correspondence, newsletters, etc., dealing with the Class Gift Committee (Sayler was chairman), the Class History, or plans for and reports on Class Reunions. Several printed items (yearbooks, West Point periodicals, etc.) were turned over to the Eisenhower Library book collection.

The third series, making up approximately one-half of the collection, could be called General Sayler's official file. This is a series of folders maintained by his secretary. The first few folders are titled by subject and deal with administrative matters – travel, awards, promotions, invitations, speeches, congratulatory letters, etc. The remainder of the series consists of a chronological arrangement of incoming and outgoing correspondence (forms, letters, orders, memos, etc.) in numbered folders. This correspondence is of an official nature, dealing with General Sayler's work in the Ordnance Department of the Army during and after World War II. Major correspondents include General John C.H. Lee and General Levin Campbell, under whom General Sayler served during World War II.

It is worth noting that this third series, General Sayler's official file, contains material on a wide variety of subjects of interest to the modern military historian. These subjects fall into two chronological categories: the period from 1942 to 1945 when General Sayler was Chief Ordnance Officer, ETO, and the period from 1945 to 1949 when he was Chief of Research and Development in the Ordnance Department. The most fully documented matters for the 1942-1945 period are the administration of the ordnance supply system in the ETO, the administration of ordnance maintenance and repair, the operation of French firms producing artillery parts and repairing U.S. tanks, the alleged ammunition shortage in the ETO of November 1944, the production of overall survey reports of ordnance supply in the ETO, the returning of ordnance

from the ETO to the U.S., the transfer of officer personnel between the U.S. and ETO ordnance assignments, and the negotiations between Sayler and Swiss firms to effect the repair of U.S. automotive and tank parts. The treatment of subjects for the 1945-1949 period is less detailed, but there are significant references to the reduction of tank and automotive production for the army's Detroit arsenal, the development of the U.S. rocket and missile program, the increased hiring of civilian personnel for ordnance projects to gain continuity in long-range projects, the Ordnance Department's relations with contractors and civilian employees, the British proposals for Anglo-American cooperation in ordnance development, the development of the Brandt-Rifle Grenade and its testing in Switzerland, the problems of promotions for officers in the post-war army, and Sayler's reflections on the operations of ordnance in the ETO and the organization of the Communications Zone (Com Z).

Oversize items: The half-suit box at the end of the collection contains oversize items (appointments, certificates, diplomas, and other memorabilia) from all three series.

Seven items, parts of uniforms, were turned over to the Eisenhower Museum. A total of 178 photographs were turned over to the Eisenhower Library Audiovisual Collection. Sixteen books and one magazine were turned over to the Eisenhower Library Book Collection.
